Executive Disorder 1964-08

WHEREAS, Mordor, oops-- Morton County is currently experiencing severe winter weather storm conditions, and it is anticipated harsh winter conditions will continue until next spring as it has for time immemorial at this latitude; and

WHEREAS, winter conditions have the potential to endanger human life, especially when they are exposed to these conditions soaked in water from water cannons, while dodging rubber bullets, in a deep fog of tear gas and dodging concussion grenades; and

WHEREAS, large populations of Sioux and their allies have chosen to camp at Oceti Sakowin on treaty lands as their ancestors have done for thousands of years, in semi permanent structures, like Tipis, which have not been inspected and approved by Mordor Country as proper dwellings suitable for winter habitations; and

WHEREAS, the aforementioned areas of Oceti Sakowin are not zoned for proper dwellings like the Man Camps in the Bakken Oil Fields; and

WHEREAS, the United States Army Corps of Engineers has ordered the aforementioned area of Sioux Treaty Land to be the unceded lands of great Sioux nation according to the Treaties of Ft. Laramie of 1851 and 1868. The Army Corps respects the Great Sioux Nation's wishes and has asked DAPL to vacate the sacred grounds due to public safety concerns related to DAPL's inability to guarantee that a pipeline won't break, ruining the water for the 17 million people that live downstream and that they will not disturb sacred burial ground risking the spiritual fury of disturbed ancestors; and

WHEREAS, it is the responsibility of the state to assist oil companies and their cronies that their financial investment in DAPL at the expense of it's citizens and visitors. The Water Protectors are creating hardships for investors and the state will issue orders to block public roads, withhold emergency vehicles (after hosing off water protectors in freezing temperatures) and any order in the best interest of private oil interests; and

NOW, THEREFORE, I, Jack "Sauron" Dalrymple, Governor of the State of North Dakota, order mandatory evacuation of my bowels on to Treaty Rights, the Constitution, Civil Liberties, Democracy, the city's coffers, the Missouri River, and on any semblance of human dignity and rule of law. This evacuation will shall remain until I'm removed from office, Treaty Rights are honored, the Black Snake is destroyed, and the Sheriff is arrested for civil rights violation and war crimes.

All persons in the press, including CNN, ABC, PBS, NBC and FOX shall NOT mentioning the stench that I'm making.

Any action or inaction taken by any party which encourages persons to enter, reenter, or remain in the evacuation area will be subject to strip search, asked to squat and cough in front of opposite gender officers, and placed in a dog kennel as defined by my Orc Sheriff Kirchmeier.

I direct state agencies, emergency officials and nongovernmental organizations to stay away out of my evacuations because I love my children and only I know what's good for them.

Any person who chooses to enter, reenter, or stay in the evacuation does so at their own risk, and assumes any and all corresponding liabilities for their unlawful presence and occupation of the evacuation areas.

This order is issued pursuant the following authority and for the following reasons:

- 1) The Governor is vested in his stocks at ETP (DAPL).
- 2) The governor is vested with assault and battery on Water Protectors.
- 3) The governor is vested in keeping the Great Sioux Nation as wards of the state vs. treating them like a sovereign state.
- 4) A coordinated and effective effort for all state departments is required to keep the pipeline on schedule for completion. Failure to do so by Jan 1, 2017 will be a disaster and create a personal financial emergency for the governor.

This order is effective immediately, and it shall remain in effect until rescinded.
